# CANYON HORSE ARENA RENTAL AGREEMENT

Renters of the Canyon Horse Arena (or the applicant on behalf of the renter) hereby agrees to the following terms and conditions:

1. Event cancellation: fifty percent (50%) of the rental fee will be refunded only when notification is received by the CCA not less than 14 days in advance of the rental period. Weather dependent cancellation, will be considered with possible refund.
2. All equipment, displays and other goods brought to the Arena shall be the responsibility of the renter. CCA assumes no responsibility for any damage or loss of such equipment whatsoever.
3. Liquor consumption prohibited anywhere in park with the exception of your campsite unless authorized by a Special Occasion License issued under the BC Liquor Control Licensing Act.
4. The renter will comply with all applicable fire, safety and liquor regulations and shall be responsible for the conduct of all persons attending the event during the period covered by this rental agreement. **Renter/signatory assumes responsibility for any and all damage to the Park and Arena premises.**
5. Washrooms provided with paper towel and toilet paper. Coin operated showers available - \$1.00
6. Horse trailers/vehicles to be parked in designated equestrian area, away from ball diamond fence.
7. Horses and horse activities to remain in designated horse use areas ie. no wandering through playground, upper parking lot, fitness trail, etc.
8. If it poops, scoop - please scoop poop from arena and deposit in designated area. Shovel and wheelbarrow will be provided and must be returned with key.
9. No feeding of animals in the arena
10. Arena is not to be used as a stable or overnight corral
11. No harrowing the arena unless pre approved to do so
12. Minors will be supervised by adults in charge
13. Dogs must be on leash
14. Power is available at the announcers stand (upstairs) for speaker systems and timers only
15. Insurance waivers, attached, must be signed prior to event. These Insurance waivers are valid from January 1 to December 31 and must be renewed annually. Applicant must ensure all participants sign insurance waivers prior to event.
